- The Company reserves the right to collect advance order. All orders are subject to availability of stock.
- The Dealer Prices (DPL) mentioned in this Price list are subject to change without prior notice. In the event of a revision in prices, the prices ruling at the time of delivery will apply.
- A cash discount (CD) will be allowed on the Dealer Price list, net of all Bill Rebates & Discounts allowed in the invoice to the dealers who made / settled payments as per the Credit Policy of the Company.
